#### 2 Service

#### 2.1 Description

The ERA Acute methodology was implemented as industry standard for environmental risk assessment (ERA) on NCS in 2019, and the Service is a desktop software application developed to support performing environmental risk assessments based on this methodology.

The Service provides a software tool with relevant visualization of the output results from the ERA Acute method, such as maps, graphs and tables. The tool has applications for environmental risk management, such as a risk matrix and a comparison tool which may support a spill impact mitigation analysis (SIMA) to evaluate that the best response is chosen to minimize impact of oil spills on people and the environment.

#### 3 Service fees

#### 6 Termination

Terms in the General terms section 8 – "Termination" applies with following additions:

- Article 8.6 is not relevant as the Service is a software installed on the User's computer, and data stored locally on the User's computer.
- User organisation is responsible for ensuring that software is uninstalled from User's computers.

## 7 NOROG's additional obligations

# 8 User organisation's additional obligations

Terms in the General terms section 14 – "User organisation's general obligations" applies with following additions:

- Each User organisation must appoint and maintain an administrative contact point, acting as the User organisation's overall ERA Acute Software user administrator. These responsibilities include:
  - a) Being responsible for the User organisation's administration of own Users towards NOROG
  - b) Having the authority to act as main contact towards NOROG concerning the User organisation's use of the Service.
