2 Service

2.1 Description

Provides a single point of interaction for Operators to communicate reports both towards partners and authorities.

A service designed to comply with requirements. A flexible knowledge database for receiving, validating, storing and transmitting reports from the operators to partners and authorities with sufficient access control and security.

ReportingHub currently accepts:

- Daily Drilling Reports
- Daily Production Reports
- Monthly Production Reports

The reports are validated and stored in ReportingHub, for the operators and partners to download.

ReportingHub delivers data to License2Share, DISKOS and SMIL for communication to Norwegian Petroleum Directorate.

2.4 Service level

2.4.1 Availability

The goal is that the Service should be available at all times, except for during standard maintenance windows as described below.

2.4.2 Standard Maintenance window

Standard Maintenance windows (planned maintenance) are used for carrying out technical and functional updates.

- Technical updates: Typically performed monthly, with the goal of not affecting the availability of the service.
- Functional updates: Performed in relation to releasing new functionality in the service. Maintenance notifications are published on the service login-page and/or in e-mail to the Users minimum 7 days in advance.

2.5 Data management

2.5.1 Data Ownership

User organisation shall retain all rights to all data which the User organisation, or a Third party on behalf of the User organisation, submits to the Service.

2.5.2 Use of data

2.5.2.1 User organisation's use of data from the Service

Data retrieved from the Service shall only be used in accordance with the purpose of the Service.

2.5.2.2 NOROG's use of data

NOROG will only use data provided by the User organisation in such ways and to such extent as is necessary to operate, maintain and improve the Service and related services. The User organisation acknowledges and agrees that NOROG, on a non-discriminating basis, may use aggregated statistical data related to the usage of the Service.

2.5.2.3 Data distribution to external systems

The Service distributes uploaded data according to pre-defined routes, using API interfaces provided by License2Share, DISKOS and SMIL.

3 Service fees

- No Service fee applies as cost for operation is covered by the Members through the Member fee. Non-Member organisation's cost is limited to yearly Administration fee according to www.epim.no/fees.

5 Security

- For an interim period ReportingHub API is only accessible via the oil & gas industry network SOIL.
- Service API authentication is based on OAuth 2.0.

6 Termination
